



## Campaign Signs

### Responses to Common Questions

This Frequently Asked Question (FAQ) sheet provides responses to the more common questions Poway residents and candidates post to staff related to campaign (political) signs. Following each response is the applicable code section should you want to learn more about the sign requirements.

#### **IS THERE A TIME LIMIT TO WHEN I CAN POST CAMPAIGN SIGNS; I.E. BEFORE OR AFTER AN ELECTION?**

No. With recently adopted Ordinance No. 16-791, an unlimited number of temporary signs displaying political or other noncommercial messages are permitted on private property at all times as long as the posting is done with the property owner's permission. (PMC §17.40.090.D.4)

#### **IS THERE A SIZE LIMIT TO THE CAMPAIGN SIGNS I CAN POST ON PRIVATE PROPERTY?**

Yes. Although there is no limit on the quantity of temporary campaign signs allowed on private property, there is a limit on the size of each individual sign. Signs shall not exceed six square feet (each side) with a maximum height of four feet. (PMC §17.40.090.D)

#### **CAN I REPLACE THE MESSAGE ON AN EXISTING SIGN WITH A CAMPAIGN MESSAGE?**

Yes, with limitations. The area of any existing legally displayed sign may be converted. However, the converted sign must comply with any code limitations, design standards, and/or permit processing requirements. (PMC §17.40.020 - §17.40.040)

#### **CAN I PLACE SIGNS IN THE PUBLIC RIGHT OF WAY?**

No. Signs are not allowed in the right-of-way, which is generally along roadsides and sidewalks (PMC §17.40.090.D). If you have any questions where the right-of-way is, please call 858-668-4656.

#### **HOW DOES THE CITY ENFORCE THESE REGULATIONS?**

The Code Compliance Division within the Development Services Department is the City's lead on the enforcement of signs. Signs placed in the right of way will be removed immediately. In instances of signs placed on private property which do not follow city regulations, the property owners will be notified and abatement will be conducted.

#### **WHAT DOES THE CITY DO WITH REMOVED CAMPAIGN SIGNS?**

In the event a sign is removed, code compliance staff will contact the owner of said sign and coordinate pick-up.
