To participate in the Permanent Special Agricultural Water Rate Program (PSAWR) as established by the San Diego County Water Authority (SDCWA) and administered locally by the City of Poway, a Property Owner is required to provide the following information, provide written consent, certification and acknowledgment as indicated on this form.

Failure to complete all sections and/or provide requested documentation may result in ineligibility.

SECTION 3 – VERIFICATION OF COMMERCIAL AGRICULTURAL SALES:

To qualify for participation in the PSAWR, applicants must annually provide proof of commercial agricultural sale of products grown on the participating property. Examples of verification include:

- o Current bills of sale or invoices for the agricultural commodity produced on your property;
- o A contract between you and a commercial grove manager for your property; or
- o Tax records to verify commercial agricultural sales.

One or more of these examples, or something similar, must be provided at the time this application is submitted.

Concurrent with the completion of this Enrollment Form, the City of Poway will determine if the Commercial Agricultural Operation is included on one of the following lists (**Only 1 Required**):

- o Grower’s List
- o Active Certified Producers List
- o Organic Producers List
- o Regional Board General Agricultural Order Enrollment List

SECTION 4 – CONSENT TO PARTICIPATE AND ACKNOWLEDGEMENT:

I hereby certify that I am the owner, or authorized agent of the owner, of the above referenced property and consent to participate in the Permanent Special Agricultural Water Rate (PSAWR) Program and that the information provided herein is true and correct. I further certify that water purchased under the PSAWR water rate will be utilized in accordance with the rules of the PSAWR, and for agricultural purposes as defined by the San Diego County Water Authority (SDCWA).

I understand that in addition to the information I have provided herein, a field audit of my property may be conducted by the City of Poway and/or the San Diego County Water Authority to verify the agricultural use.

I hereby acknowledge that water received under the PSAWR water rate is a non-firm, interruptible supply, subject to early and accelerated mandatory supply reduction, based upon water supply conditions as determined by the SDCWA and may be subject to financial penalties for exceeding allocation. I acknowledge that water use under the PSAWR water rate is subject to periodic examination, and I agree to respond in a timely manner to requests for information and access to properties. I further understand that failure to provide a reasonable response and access will result in automatic termination of the PSAWR water rate.

I hereby acknowledge as a participant in the PSAWR that I understand by signing this Enrollment and Acknowledgement Form that I am enrolled into the Permanent Special Agricultural Water Rate Program and will not be allowed to opt out of the PSAWR water rate during or under substantial threat of a mandatory water supply reduction.

In the event my property is not eligible for certification, I understand that I will no longer receive the PSAWR discount, but I may still be subject to the mandatory reduction for PSAWR customers.

I further acknowledge that water purchased under the Program, but done so on the basis of incorrect information supplied by the applicant in Section 2 of this form, or water utilized for uses other than agricultural purposes as defined by SDCWA in Section 1, may result in an assessment by the City of Poway of water rates, penalties and charges as required by SDCWA, which I hereby agree to pay.
